WAIVER, OPERATOR AGREEMENT, RELEASE, HOLD HARMLESS, AND INDEMNIFICATION AGREEMENT

As consideration for being allowed to enter the play areas and/or participate in any party and/or program at Jolly Hoppers, Ltd., the undersigned, on his or her behalf, and on the behalf of the Participant(s) identified below, acknowledges, appreciates, understands, and agrees to the following:

- 1) I represent that I am the parent or legal guardian of the Participant(s) named below or I have obtained permission from the parent/legal guardian of the Participant(s) named below to execute this agreement on their behalf.
2) I acknowledge and understand that there are risks associated with participation in Jolly Hoppers, Ltd., activities and the use of the play areas and inflatable equipment including but not limited to: contusions, fractures, scrapes, cuts, bumps, paralysis, or death.
3) I, for myself and the Participant(s) named, willingly assume the risks associated with participation and accept that there are also risks that may arise due to OTHER PARTICIPANTS which I also willingly assume.
4) I agree that the Participant(s) named, and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions for participation in any party and/or program at Jolly Hoppers, Ltd.,

OPERATION/RIDE RULES: S-in-1 Combo: 6 participants bouncing maximum at a time with a 220 lbs. maximum weight limit per participant. Castle Combo 7: 6 participants bouncing maximum at a time with a 200 lbs. maximum weight limit per participant. Magic Castle: 20 participants bouncing maximum at a time with a 150 lbs. maximum weight limit per participant. My Little Farm: 10 participants bouncing maximum at a time with a 80 lbs. maximum weight limit per participant and a maximum age of 4 years. Indoor Modular Jump: 8 participants bouncing maximum at a time with a 100 lbs. maximum weight limit per participant and a maximum age of 4 years. Obstacle 32: 8 participants Maximum at a time entering 2 at a time and only 2 participants sliding at a time. 175 lb. maximum weight limit per participant.

ALL riders have a minimum height requirement of 34" in order to play on their own. Under 34" requires an adult Parent/Guardian/Operator to assist at all times. On all slides, participants must slide feet first and on their bottoms. No diving, hanging, climbing, flipping, pushing, shoving, wrestling or rough play on any equipment. If there are any problems, notify a Staff Member immediately.

5) YOU ARE THE OPERATOR: I HAVE READ and UNDERSTAND the OPERATION/RIDE RULES, agree to MONITOR and OPERATE any RIDE at this facility on the behalf of ANY RIDE PARTICIPANT. I agree to enforce ALL Jolly Hoppers, Ltd., safety RULES and agree that the failure of myself or any participant to follow these rules may result in injury or death.

6) I, for myself, the Participant(s) named, our heirs, assigns, representatives, and next of kin agree to hold harmless and indemnify Jolly Hoppers, Ltd., their predecessors, parent, subsidiaries and affiliates, officers, and employees from any and all injuries, liabilities or damages which are in any way connected with participation in this activity, use of Jolly Hoppers, Ltd.'s equipment or facilities, arising from Jolly Hoppers, Ltd.'s negligent conduct, the conduct of other participants, or my own negligence. This release does not apply to claims arising from intentional conduct.

7) I additionally agree to indemnify Jolly Hoppers, Ltd., their predecessors, parent, subsidiaries and affiliates, officers, and employees for my defense cost or expense arising from any and all claims, injuries, liabilities or damages arising from participation.

8) I am of physical ability to participate, operate rides, and I am legally competent to understand and complete this agreement. I hereby execute this agreement without coercion.
